**CONVERSION OF TERM GOLFING (BASIC / ENHANCED) MEMBERSHIP TO  
TRANSFERABLE GOLFING MEMBERSHIP (LOCAL / FOREIGN)**

**Terms & Conditions**

1. An existing Term Golfing Member who has been with the Club for at least a consecutive period of 3 years shall have the option to apply for the conversion of his Membership to a Transferable Golfing Membership if he is a Singaporean or Singapore Permanent Resident, or a Transferable Golfing (Foreign) Membership if he is not a Singaporean nor a Singapore Permanent Resident.
2. The conversion fee shall be computed as follows:

<b>Membership Type</b>	<b>Transferable Golfing</b>	<b>Transferable Golfing (Foreign)</b>
<b>Term Golfing (Basic)</b>	Market Price* of Transferable Golfing Minus Entrance Fees paid to date.	Market Price* of Transferable Golfing (Foreign) Minus Entrance Fees paid to date.
<b>Term Golfing (Enhanced)</b>	Market Price* of Transferable Golfing Minus 50% of Entrance Fees paid to date.	Market Price* of Transferable Golfing (Foreign) Minus 50% of Entrance Fees paid to date.

3. The Market Price shall be determined based on the average price of transactions for the last 3 months prior to the application for conversion. Should there be no transactions in the said period for Transferable Golfing (Foreign) Membership, the Market Price shall be computed based on 125% of the average price of Transferable Golfing Membership for the said period. The Club's decision on the amount of conversion fee payable shall be final and binding.
4. The conversion fee shall be paid in one lump sum upon application for conversion.
5. Upon conversion of a Term Golfing Membership to a Transferable Golfing Membership or Transferable Golfing (Foreign) Membership, the Member shall be entitled to the same privileges as a Member in those categories.
6. The Member shall pay the prevailing monthly subscription fee of a Transferable Golfing Member after converting to a Transferable Golfing Membership or Transferable Golfing (Foreign) Membership.
7. All fees stated above are subject to GST.
8. All applications, including that for subsequent renewal or conversion of membership, are subject to the approval of the General Committee. The Club reserves the right to reject any application without having to assign any reason whatsoever.
