### APPLICATION FOR ABSENTEE STATUS

I fully understand and agree to abide by the following terms and conditions of Absentee Status.

#### **TERMS AND CONDITIONS OF ABSENTEE STATUS**

1. Absentee Status may be applied from a **minimum of six (6) months (under Constitution Rule 23.1) to a maximum of two (2) years**. Any period after two (2) years is subject to the Club's approval, which has to be applied in writing one month before the expiry of the previous application, and that all amounts due by the Member to the Club should also be paid up.
2. The absent membership subscription fee is 30% of the prevailing monthly subscription fee and should be paid in full for the duration of the absent period upon application before going on absentee. This fee must include the current GST amount.
3. Documentary proof is required and should be submitted with the application for absentee to the Club to certify absence from Singapore.
4. Activation request must be made in writing after the initial 6 months of approved absent period. Such notice must be received by the Club at least 7 days before the first day of usage. The full subscription fee will be charged for the period of use, regardless of whether the usage is for a full or partial month.
5. The Club reserves the right to request for proof of exit from and return to Singapore for any application made.
6. Spouses and children of absent members are not entitled to make use of the facilities during the approved absentee period.
7. An absent member who is found to be using the Club's facilities during his or her absentee period without prior activation of membership will be subjected to disciplinary action\*.

\*A member wishing to use the Club's facilities before the minimum requirement of 6 months of absentee period would be required to sign an activation form. The membership shall be activated immediately and the monthly subscriptions shall be payable henceforth. The full monthly subscriptions payable shall include the months preceding the membership activation.

#### **I enclose herewith the following:**

- 8a. A cheque in payment of the Absent Membership subscription fee and my outstanding account made payable to "**Jurong Country Club**".
- 8b. Documentary proof from an organisation or visa/permit from Immigration or Government bodies to confirm overseas vocation/ stay.

*I understand that my application for Absentee Status is subject to approval by the Club.*

Note: Please be reminded to cancel all tuition classes or courses enrolled before applying for Absentee Status. All relevant documents and payment should reach the Membership Services Unit by **20th of the month**, in order for the Absentee Status to be effective on the first of the following month.
