ENHANCED GOLFING PRIVILEGES SCHEME FOR SOCIAL MEMBERS

Terms & Conditions

1. A Social Member may enroll for the Enhanced Golfing Privileges Scheme at a fee of \$500 for a 1-year period.
2. The fee shall be paid in one lump sum upon application.
3. The Enhanced Golfing Privileges Scheme shall be available for only 50 Social Members.
4. There shall be no change to the monthly subscription fee for Social Members who are enrolled under this Scheme.
5. The fee stated above is for **one** Member only. Each principal or family members wishing to enjoy these privileges would have to be enrolled separately.
6. The privileges under the Scheme shall comprise:
 - i) Use of the 18-hole course and the Executive course on weekdays (except public holidays) at 50% of guest fees.
 - ii) Sign in of 7 guests per session for golf on weekdays (except public holidays) at corporate rates.
 - iii) Use of the driving range at golfing member's rates.
 - iv) Have a handicap record maintained by the Golf Section.
7. This Scheme is not transferable.
8. There shall be no refund of enrolment fee paid upon premature termination of the Scheme by the Member or cessation of the Social Membership.
9. An enrolled Member may apply for renewal of the Scheme one month before the expiry at a fee to be determined by the Club.
10. All fees stated above are subject to GST.
11. All enrolments, including that for subsequent renewal of the Scheme, are subject to acceptance by the Club. The Club reserves the right to reject any enrolment without having to assign any reason whatsoever.
