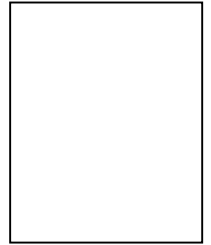

1. All applications must be made in PRINT or BLOCK LETTERS on the original application form.
2. All applicants must affix a photograph on the application form and provide another 3 photographs of him/herself, his/her spouse and children who are 12 years or above but below 21 years of age. Please note that the photographs must be passport sized.
3. All applicants must submit photocopies of his/her NRICs/Passport, spouse's NRIC/Passport, Employments/Dependents Pass, Marriage and Birth Certificates. Please note that for Singapore PR, a copy of the Re-entry permit granting unlimited access must also be submitted.
4. All applications must be accompanied by the appropriate payments including a membership deposit as follows:  
Permanent Membership : \$1,000  
Term Membership : \$1,700.  
All cheques must be crossed and made payable to '**Jurong Country Club**'. Cashing of cheques does not denote acceptance of application or election of membership.  
Note: \$700.00 would be refunded upon attendance of the 'Meet-the-Committee-Member' session.
5. All applicants should provide two referees who are members of the Club and to whom the Club can make reference. In event that an applicant is unable to provide any referee, he/she shall pay an additional \$500 for the above refundable membership deposit. The deposit for an applicant with no referee is as follows:  
Permanent Membership: \$1,500  
Term Membership: \$2,200
6. For Corporate Membership :-
  - (i) New Corporate Members must submit an 'Incorporation of Companies' Certificate from the Registrar of Companies and Businesses.
  - (ii) First-time Corporate Nominees are required to fill a separate 'Application for Membership form.

**Rule 26.2 : Any Member who:-**

- a) has resigned or died; or
- b) has been adjudicated bankrupt as from the date of such adjudication; or
- c) being a body corporate is placed in winding-up or under judicial management; or
- d) becomes an enemy alien of Singapore; or
- e) has defaulted and whose name has been deleted from the Register; or
- f) has his membership charged under any Order of Court; or
- g) has been expelled; or
- h) has been convicted of any offence involving violence or dishonesty or shall suffer imprisonment for any reason whatsoever; or
- i) leaves Singapore to escape criminal proceedings; or
- j) being an unincorporated association is dissolved or ceases to exist; or
- k) being a partnership is dissolved or any partner thereof is adjudged bankrupt or makes a composition with creditors; or

## **TERM GOLFING (FAMILY EXTENSION) MEMBERSHIP**

### **TERMS & CONDITIONS**

1. Transferable Golfing, Transferable Golfing (Foreign), Ordinary Golfing, Lady Golfing and Nominees of Corporate Golfing Members (i.e. "Eligible Principal Members") shall have the option to apply for the enrolment of up to two children, who are/were Junior Golfing Members, upon their attaining the age of 21, for the Term Golfing (Family Extension) Membership.
2. This option may be exercised for a junior golfing member who had turned 21 on or after 1 December 2003, but not later than 5 years of his 21<sup>st</sup> birthday.
3. The General Committee shall have the discretion to limit the number of Term Golfing (Family Extension) Memberships from time to time available for enrolment.
4. The nationality of the Junior Golfing Member to be enrolled shall determine the category of Term Golfing (Family Extension) Membership, whether local or foreign. Singaporeans and Singapore Permanent Residents shall be enrolled in the local category and all other nationalities in the foreign category.
5. The Term Golfing (Family Extension) Membership is for a 5-year period. The entrance fee is \$10,000 for the first enrolment and \$15,000 for the second enrolment, for both the local and foreign category.
7. A credit limit of \$5,000 shall apply for a Term Golfing (Family Extension) Member. The credit limit may be raised upon application submitted at least 2 working days prior to spending.
8. The Term Golfing (Family Extension) Member shall arrange to settle his account by GIRO on submission of his application
9. Upon application, the entrance fee may be paid in one lump sum or by interest-free monthly instalments over the period of 60 months following an initial down-payment of 20% plus prevailing GST on the full entrance fee. The instalments shall be guaranteed by and billed to the Eligible Principal Member's account. The entire remaining instalments shall become due and immediately payable and shall be settled by the Eligible Principal Member in either of the following events:
  - (i) The Term Golfing (Family Extension) Membership were to cease before the end of the instalment period for whatever reason; or
  - (ii) The Membership of the Eligible Principal Member were to cease before the end of the instalment period for whatever reason.
10. The monthly subscription fee of a Term Golfing (Family Extension) Member shall be that of the prevailing fee for Ordinary Golfing Membership.
11. A Term Golfing (Family Extension) Member may enrol his spouse and children.
12. A Term Golfing (Family Extension) Member shall not be entitled to hold office but shall otherwise enjoy all the privileges of an Ordinary Golfing Member.
13. The Term Golfing (Family Extension) Membership is not transferable.
14. During the 5-year term, the Eligible Principal Member shall have the option to apply for the conversion of the Term Golfing (Family Extension) Membership of his child into a Transferable Golfing Membership if the Membership held is the local category, or Transferable Golfing (Foreign) Membership if the Membership is the foreign category, by paying a conversion fee. For a conversion to a Transferable Golfing Membership, the conversion fee shall be computed based on the difference between the Market Price of Transferable Golfing Membership at the time of application for the Term Golfing (Family Extension) Membership and \$10,000. For a conversion to a Transferable Golfing (Foreign) Membership, the Market Price of Transferable Golfing (Foreign) Membership shall apply instead. The Market Price shall be determined based on the average price of transactions for the last 3 months prior to the application for Term Golfing (Family Extension) Membership. Should there be no transactions in the said period, the last transacted price shall be used. The Club's decision on the amount of conversion fee payable shall be final and binding.
15. Upon exercising the option to convert, the conversion fee may be paid in one lump sum or by interest-free monthly instalments over a period of 36 months following an initial down-payment of 20% plus prevailing GST on the full entrance fee. The instalments shall also be guaranteed by and billed to the Eligible Principal Member's account. The entire remaining instalments shall become due and immediately payable and shall be settled by the Eligible Principal Member in either of the following events:
  - (i) The Transferable Golfing Membership of the Junior Golfing Member were to cease before the end of the instalment period for whatever reason; or
  - (ii) The Membership of the Eligible Principal Member were to cease before the end of the instalment period for whatever reason.
16. Upon conversion of a Term Golfing (Family Extension) Membership to a Transferable Golfing Membership or Transferable Golfing (Foreign) Membership, the Member shall be entitled to the same privileges as a Member in those categories.
17. The Eligible Principal Member shall indemnify the Club for a period of 5 years from the effective date of the Term Golfing (Family Extension) Membership in respect of all payments due by his child(ren) that are not recoverable by the Club.
18. All fees stated above are subject to GST.
19. All applications are subject to the approval of the General Committee. The Club reserves the right to reject any application without having to assign any reason whatsoever.
